Florence Palpacuer is Professor in Management Studies at the University of Montpellier (France), where she is codirector of a Chair on Responsible Management and Enterpreneurship funded by the French National Research Agency. She has been studying globalization processes and their social consequences from a management perspective over the last 20 years.



Her recent interests include workers' resistance and social justice movements in global value chains. She is a co-founder of the Responsible Global Value Chains initiative established in 2016.

Sarah Dadush is the Director of the Responsible Contracting Project (RCP) and Law Professor at the Rutgers Law School. A business and human rights law scholar-practitioner with a background in international development, she teaches Contracts, Business & Human Rights and Consumer Law.



She leads the ABA's Business Law Section working group on model contract clauses, the MCCs 2.0, that companies in any sector can include in their supply contracts to improve human rights in their supply chain. She directs the RCP, which aims to improve human rights in global supply chains through innovative contracting practices.

She is Full Professor of Private Law at the Faculty of Law of the University of Trento. She coordinates several projects funded by European and International Institutions. He is senior visiting fellow at the Transformational School of governance (European University Institute). Until June 2023, he was ENEL SPA Géneral Counsel.
