Objectives

Guiding questions for the conference are how to make the Rule of Law-principle concrete or operational and how to assess it. Therefore, the interrelation between developing conditionality benchmarks in the enlargement process and the need for reacting to the Rule of Law-crisis within the EU is explored as it has led to the development of a common methodology by mutual influence. Within the broad topic of judicial reforms, the focus will be on judicial independence (and accountability) as well as – institutionally – Constitutional Courts and Judicial Councils.

Structure

A first panel will introduce the Rule of Law-principle and summarize the work of the Venice Commission in the fields of judicial independence, Constitutional Courts and Judicial Councils. It will also add a view on the Eastern Partnership countries, with a focus on Armenia. The second panel will be dedicated to the role of Constitutional Courts as guarantors of the Rule of Law-principle, while the third panel will focus on Councils of the Judiciary as self-governance bodies guaranteeing judicial independence.

In each panel, the three geographical areas, i.e. the EU Member States, the Western Balkans, and the “Trio” (Ukraine, Moldova and Georgia), will be represented and analyzed by one presentation each. All topics will be discussed from a comparative perspective (illustrating, for example, the Venice Commission Opinions, the European Commission’s country reports etc).
